## The Cambodian Center for Human Rights ("CCHR") Commemorates the Fifth Anniversary of the Death of Dr. Kem Ley

10 July 2021 marks the fifth anniversary of the death of Dr. Kem Ley, a political analyst and media commentator who was shot and killed while having his morning coffee at a gas station in central Phnom Penh on 10 July 2016. Following a speedy investigation – which lacked both thoroughness and independence – authorities arrested a man named Oeuth Ang, who identified himself as "Chuob Samlab" (meaning "Meet to Kill" in Khmer) and who "confessed" to the killing. Following a half-day trial on 23 March 2017, which was widely criticized for its failure to meet international fair trial standards, the Court found Oeuth Ang guilty of murder and sentenced him to life imprisonment. On 24 May 2019, the Supreme Court upheld his sentence.

To commemorate the fifth anniversary of the death of Dr. Kem Ley, to remember his legacy and honor his contribution to Cambodian society, CCHR is organizing a campaign on social media which will include the following activities:

- From 1 31 July, CCHR will change its Facebook page cover to display a picture and a quote from Dr. Kem Ley;
- From 2 7 July, CCHR will post a series of quotes from Dr. Kem Ley along with his photo on its Facebook page;
- From 5 31 July, CCHR will hold an online event, inviting the public to share their memories of Dr. Kem Ley and their messages for him;
- On 6 July, CCHR will conduct a radio talk show on the topic "Remember Kem Ley";
- On 8 July, CCHR will release a video titled "Kem Ley's Life Journey" on its Facebook page;
- On 9 July, CCHR will:
  - o conduct a radio talk show on the topic "Fifth anniversary of Kem Ley's death"; and
  - o release a video showcasing messages from people who were close to Dr. Kem Ley;
- On 10 July, CCHR will release an infographic on impunity, highlighting Dr. Kem Ley's case but also explaining what impunity is, what are the negative consequences of it and how to fight against impunity.
